Collin County Community College District students who meet Texas Woman's University admissions requirements upon completion of studies at CCCCD and/or completed the Associate of Arts/Science degree at CCCCD, will receive automatic admission to Texas Woman's University. Students may apply for concurrent pre-admissions status at the time they enroll at Collin County Community College District or at the beginning of their second year of study at CCCCD by completing and sending this form to the TWU Office of Admissions (see address below). The form must be signed by an appropriate CCCCD official (such as the Registrar or an Academic Advisor) to confirm that the student is being acknowledged by CCCCD for participation in this program.

Participants must then complete the transfer Texas Common Application (paper or electronic version) and submit official transcripts of all college work attempted within 12 months of anticipated enrollment at Texas Woman's University in order to initiate the formal admissions process at TWU. To apply electronically, go to www.applytexas.org and follow the online instructions, selecting the Transfer application and TWU as the target institution.

NOTE: Participation in the TWU Bound Program does not guarantee admission to a specific college, program or major at TWU. Students should contact the specific academic department for admission information.
