SAMPLE STATEMENTS FOR THIRD YEAR PERIODIC PERFORMANCE REVIEW (MID-TERM REVIEW)

Each faculty member will provide a brief statement of accomplishments relative to the AC criteria applicable to his/her faculty appointment. These brief statements will typically be 1-2 pages in length for each of the 3 domains: Teaching, Scholarship, and Service. A faculty member may elect to include a brief opening statement and a brief conclusion. The review period for the PPR for years 3-5 of faculty employment is the prior academic year. These brief statements will typically be 1-2 pages in length for each domain.

In addition, a tenure-track faculty member will receive a “mid-probationary period” “or “pre-tenure” review. This will typically occur as an additional part of the 3rd year review. For clinical or lecturer faculty, this additional review will serve as a “mid-term” review prior to potential application for promotion to the next rank.

Within each of the statements for the three domains, it is recommended that a 3rd year faculty member include a cumulative summary of accomplishments for their mid-tenure or mid-term review. These statements may begin as follows:
