

Texas Tomorrow/Guaranteed Tuition Plan

How do I use my Texas Tomorrow/Guaranteed Tuition account?

You should provide the University with a copy of your Texas Tomorrow (TTF) or Guaranteed Tuition Plan card. If your ID card is not available, please provide a copy of the letter/statement from Texas Tomorrow with your ID number on it. You should contact the Bursar's Office prior to the first semester you register for classes with this information. After your initial registration, your student account will reflect the Texas Tomorrow plan credit for each semester as long as you have hours in your plan. You should notify the Bursar's Office at 940-898-3570, or by email to payments@twu.edu if you *do not* want to use your plan. Please include contact information, student ID number, phone and/or email address so that we may contact you if necessary.

Where do I go to turn in my Texas Tomorrow card or letter?

All Texas Tomorrow Fund information should be submitted to the Bursar's Office on the Denton campus, located in the Admissions Building. The cashier windows are open Monday through Thursday, 9 am – 4 pm. The information can also be faxed to 940/898-3578.

Will the Texas Tomorrow/Guaranteed Tuition Plan pay for all tuition/fee charges?

No, the Texas Tomorrow Fund pays for the tuition and mandatory fees for the number of hours you are enrolled for the current semester. The student is responsible for paying the course fees, lab fees, insurance, housing/meals, parking, and any other fees not covered by the plan in accordance with the payment deadlines.

Texas Tomorrow will pay for the total number of tuition hours and fee terms that have been purchased under the student's plan. Students will be responsible for paying additional tuition hours not covered by their plan. Mandatory fees (that all students are required to pay) are covered for a limited amount of semesters based on the fee terms available in the plan. If the plan is used for graduate students, the Texas Tomorrow Fund determines an hourly rate for tuition and fees that will be credited. This amount usually will not fully cover all the tuition/fee charges.

Will changes to my semester schedule affect my Texas Tomorrow Plan balance?

Yes, any schedule changes after your Texas Tomorrow Plan is credited may affect the plan. Since the credit of your plan is manually processed at the University, any addition, deletion or change in courses may affect the plan and additional charges may result. Please contact the Bursar's Office at 940-898-3570, or by email to payments@twu.edu and copied to rjramon@twu.edu to advise the office of schedule changes that occur *after* credit for the plan has been applied for the current semester. The Texas Tomorrow Plan will be applied within 10 days of the posted payment deadlines each term and will be reflected as a Sponsor Credit on the student registration statement.

Texas Promise Fund

Students using the Texas Promise Fund must have the owner of the plan assign units to Texas Woman's University each semester online in the Texas Promise Fund system. The university will access their database periodically before the semester starts and apply a credit to the student account for the applicable amount. There is nothing to provide to the university if using this plan.
