 - 1. Revise Test Exemption for STR for Persons with a Hearing Impairment: Propose to remove the requirement that a candidate be unable to process only written linguistic information to allow an exemption; would remove the requirement that to qualify for an exemption, a person who is already certified in another state and seeking a one-year certificate in Texas must have a recommendation from an SBEC-approved Texas educator preparation program (EPP); and would eliminate the limitation that persons who qualify for an exemption to one certification examination cannot ever take another certification examination unless they have regained their ability to process written linguistic information.
 - 2. Propose revisions to School Librarian and Reading Specialist certificates (new standards and timeline for implementation) based on feedback from SBEC-appointed advisory committees
 - 3. Provides SBEC opportunity to direct TEA staff to create path for alternative performance assessments to be used as certification exams.
