

# TEXES PREP Center TEXES Exam Policy for TWU Educator Preparation Program Candidates

Educator certification exams are an essential component of the Texas Woman's University College of Professional Education (COPE) Teacher Education Program. Our initial and professional certification education programs are designed to prepare candidates to be successful in the field of education and includes successful completion of the Texas Examination of Educator Standards (TEXES) certification exams. The TEXES certification exams are administered by Pearson on behalf of the Texas Education Agency (TEA). There are many TEXES certification exams from which to choose; the exams candidates take are determined by the certification(s) sought. The passing score on any of the TEXES exams is a score of 240 out of a possible 300. TWU candidates register with Pearson for their exams for a minimum cost of \$116 per test.

The TWU EPP limits practice testing attempts to three (3) times per exam. If a candidate has not passed an exam after three attempts, that candidate is no longer permitted to take that exam. All candidates must go through an approval process before registering for Pearson exams.

The TWU TEXES Prep Center offers practice exams during the weekday each semester. The practice exams are an excellent way to receive feedback before registering for the actual state exam and to identify areas needed for additional review. Along with the results, candidates will receive suggestions on the next steps for taking and passing the actual exam.

Our goal is to help candidates prepare to pass exams on the first attempt. We provide materials and opportunities for practice before candidates sit for exams with Pearson.

#### **General Information**

The opportunity to take TEXES Practice Exams through TWU's TEXES Prep Center is limited strictly to TWU candidates. Candidates should take their content TEXES practice exam first, PPR practice exam second, and then any supplemental exams if applicable. TWU candidates must pass the practice exam before attempting the real exam (see TWU Practice Test Passing Scores).

Practice exams are offered multiple times throughout the semester. Candidates should check the TExES Prep Center <u>website</u> schedule for dates and times. **Deadline to register: 48 hours before the exam**.

#### Cost

The cost of each testing session is \$25.00.

Core Subjects (EC-6 or 4-8): This exam is 5 hours long and each of the domains are timed differently according to the exam specifications. TWU candidates will need to pass each of the



domains before being approved to take the State Exam. Candidates will be able to retake each of the domains not passed at a separate administration; however, candidates must take the entire exam first. The cost of the exam is \$25.00 for the entire exam and each retake of each domain is \$7.00.

#### **Scores**

Test results are emailed to the student's TWU email address within 1-3 business days of the administration date. Candidates should **not** email the Prep Center for their scorecard before the 1-3 business days have passed.

# **TWU Candidates - Approval for Exams**

Before approval can be given for any TExES exam candidates must demonstrate proficiency in the subject area and readiness for the exam.

All TWU candidates must pass a practice exam for their specific content area, Pedagogy and Professional Responsibilities (PPR), the Science of Teaching Reading (STR) and supplemental (if applicable) prior to approval for any TEXES exam.



# **Testing Policies for Initial Certification Programs**

#### **Practice Exams**

**Note:** All exams are proctored through Examity. If a student attempts an exam without Examity proctoring the testing session, the testing session will count as an attempt and the testing coordinator will not grade the exam.

- 1. For candidates who have attempted a practice exam prior to July 1, 2018, testing approvals are granted on a case-by-case basis.
- 2. If the candidate passes a practice test with a score of 80% or higher on the first attempt, he or she will be given approval to attempt the TEXES exam.
- 3. If the candidate does not pass a practice test on the first attempt, he or she will:
  - a. Receive a score report to review Domains and Competencies where test items were missed.
  - b. Wait at least two weeks before attempting a second time.
  - c. During these weeks, students are encouraged to use a third-party study resource (e.g., Certify Teacher, 240 Tutoring) to prepare; students should contact the Testing Coordinator for a list of resources and related materials.
- 4. If the candidate does not pass a practice test on the second attempt, he or she:
  - Effective June 25, 2020, students must wait <u>at least two weeks</u> before trying again.
- 5. Each candidate will have no more than three attempts to pass any given practice test. After the third failure, the candidate will:
  - a. Be advised to transfer to the BS in Education non-certification degree or drop the Education minor if secondary/all-level (if the test not passed is the PPR or content).
  - b. Be advised to change his or her degree plan (i.e., drop supplemental certification in special education, ESL, or bilingual) if that is the only practice test the candidate doesn't pass by the third attempt.

# **TExES (State) Exams**

- 1. If the candidate passes a TExES exam on the first attempt, that is ideal.
- 2. If the candidate does not pass the TEXES exam on the first attempt, he or she will:
  - a. Wait a **minimum** of 30 days prior to registering for a second exam.
  - b. Use 240 Tutoring or other third-party study resources (during the waiting period) to study and pass the appropriate exam (i.e., equivalent to the TExES exam) with 90% or better. Documentation of this must be submitted (along with the other documentation in "c" below) to obtain a second approval. Candidates should email <a href="mailto:texesprep@twu.edu">texesprep@twu.edu</a> for a discount code, if available.
  - Document a success plan via Tk20 in conjunction with the Testing
     Coordinator. The success plan may include meetings with instructors to
     review domains and competencies, a meeting with the Education Student

Affairs Committee, and/or the use of additional resources to demonstrate readiness to attempt the exam a second time.

- 3. Once a candidate completes the above steps, he or she can request to receive a second approval from OEPS. If approved, the candidate may register and attempt the exam within a <u>minimum</u> of 30 days of receiving the second approval. If there is limited administration of the exam, the candidate must attempt the exam on the next available testing session. If the candidate does not register and test by published deadlines, the candidate must complete a TWU EPP Appeal Form and submit evidence and justification to receive a second approval.
- 4. If the candidate does not pass a TEXES exam on the second attempt, he or she will follow up with OEPS and his or her faculty advisor for additional instructions, which may result in additional coursework, dropping supplemental certification(s), or change/transfer to a different degree (e.g., BS Education non-cert., drop EDUC minor, etc.).

All students must be admitted to the TWU Educator Preparation Program and be in good standing with the university to take an actual TExES exam.

#### **Practice Testing through 240 Tutoring**

**Effective September 6, 2022**, students have the choice of either taking the TEXES Prep Center (TPC) practice tests or the 240 Tutoring pretests, modules and posttest.

If a student chooses the **TPC practice tests** all guidelines remain the same. Students will have three (3) attempts to pass with an 80% or higher to be given approval for state testing. The cost of the practice tests also remains unchanged. For more information please visit the <u>TExES Prep Center</u> site. If a student chooses the **240 Tutoring** option then the student will need to inform Mrs. Katy Eshelman (keshelman@twu.edu) or Ms. Linda Kobler (lkobler@twu.edu) that the test has been completed in order to confirm the passing rate of 80% or higher before approval for the state test will be given. Students will purchase 240 tutoring but are able to request a discount code. Please email texesprep@twu.edu to request the discount code.

A student must decide to take either the TPC practice tests **or** the 240 Tutoring tests and those will be reviewed for state test approval. **The tests do not mix and match.** 

Students whose content area is **not offered on 240 Tutoring** will continue to take the practice tests with the TEXES Prep Center.

Candidates must score an 80% or higher on all practice tests in order to be approved for a state test. Candidates have no more than three (3) attempts to pass any given practice test with a minimum three (3) week waiting period between attempts.

The deadline to have all practice and state tests passed to be eligible to student teach in a **fall semester is July 1st.** 

The deadline to have all practice and state tests passed to be eligible to student teach in a **spring semester is December 1st.** 

## **Academic Testing Year and Timing of Testing**

The goal of our program is for candidates to be finished with all certification requirements upon graduation. To that end, we strive to help candidates finish their testing requirements prior to the student teaching semester. To be eligible for student teaching, students must pass all state certification tests (including supplemental if applicable). If a student does not pass a TExES exam administered by Pearson, he or she must wait 30 days before retesting (state-mandated waiting period). Candidates shall register and retest 30 days after the 30-day wait period. If the candidate does not retest within the timeframe, testing permissions will be removed. The OEPS, the Testing Coordinator, or the candidate's faculty advisor are available for consultation and study planning in this event.

#### **Alternative Testing Arrangements**

Alternative testing arrangements that are supported by documentation from the Office of Disability Services for Students (DSS) and appropriate in the context of the practice exam may be provided for candidates who would not be able to take the exam under standard conditions.

**Accommodations available without pre-approval.** All candidates are permitted to take breaks to use the restroom, take medication, use an inhaler, or attend to other medical or personal needs without prior approval. Any time taken for these breaks is considered part of the candidate's available testing time.



## **Rescore Policy**

**Multiple choice questions:** A request for rescoring multiple choice questions must be made by completing a <u>TEXES Prep Center Rescore Request form</u>, which requires your name, the test date, the test name, and attach the scorecard in question. In the event that the rescoring process results in a score alteration, you will be issued a corrected score report and your records will be updated. If the original score is confirmed, you will be sent an email indicating that the original score has been confirmed. While a rescoring request can be submitted at any time, rescoring will only occur on Fridays.

**Written responses:** All written responses are scored according to standardized procedures. Scorers with relevant professional backgrounds are oriented to these procedures and are carefully monitored during scoring sessions. Written responses are not eligible for rescoring.

  - a. A student scores 80% or better on the Multiple Choice section (56/70 questions)
     AND scores all 3s on the Constructed Response portion of the exam (75%); If the student fails to meet the CR threshold, the student will be required to retake the practice exam.
  - b. A student scores all 3s (75%) on the Constructed Response portion of the exam, but does not meet the 80% MC threshold. The student can either choose to retake the exam to achieve 80% MC mastery OR can submit proof of mastery via 240 tutoring. 240 tutoring proof must show 80% or better on all principal competencies. Email TEXESPrep@twu.edu for a discount code.
  - c. If students struggle to meet either the MC or CR passing thresholds after two practice test attempts, the student will be instructed to contact ELDR faculty to schedule a meeting and create a success plan which includes reviewing tested standards, competencies, and course materials.
  - d. Additionally, if a student fails the PAIL (268) TEXES exam, approval for a second attempt will not be provided until all coursework (not including internship), AEL training, T-TESS
