Enrollment

Our spring final numbers ended on a high note. You may already be aware of the Chancellor's report of the February Board highlights. While on the third day of spring enrollment, reports indicated we were down per my report last month, but more students were able to register. On Census day (12th day of the term and time we take an official snap shot for the state records), graduate enrollment was up 1.8% (94 students).

Summer

Thus far, completed applications are up 17% (149 students), and acceptances are up 56% (119) compared to this time last year.

<u>Fall</u>

Thus far, completed applications are up 14% (215 applications), and acceptances are up 45% (106 students).

Thank you for all your hard work recruiting students and helping them to enroll. Speaking of enrollment, we had a very lively Zoom session with Dr. Heather Cato who shared the strategies she used to grow enrollment in the Literacy Education Master's program by 180%.
