ANNOUNCEMENTS AND REPORT BY DR. CAROLYN KAPINUS, DEAN OF THE GRADUATE SCHOOL

Welcome!

For those of you who are new, I'd like to give you some background on the purpose of Graduate Council. The Graduate Council is the delegate body of the Graduate Faculty. It formulates Graduate School policies and is responsible for reviewing and making recommendations on all matters affecting the University's graduate programs. Our accreditation body, The Southern Association of Colleges and Schools (SACSCOC), stresses the importance of the faculty role in the formulation of academic policies and curricular matters. This council is the vehicle for these actions, and I appreciate your willingness to serve in this capacity.

To clarify my role on this council, I am an ex-officio member. Because I am the Dean of the Graduate School, I am automatically on this committee, but I am not a voting member. I bring matters to the council's attention, sometimes pointing out the need for a specific policy and providing background information or a starting point, and the parameters regarding federal, state, accrediting, and university standards. But the ultimate final product of our academic policies and curriculum is the result of the work of this council. Thank you for your willingness to serve.

Enrollment

As of Census day, overall Graduate Enrollment is 5,322 students, down 1.2% from Fall 2023 (64 students). Of the total enrollment, 3,963 are master's students. Master's enrollment is down 1.6% - 65 students. Doctoral enrollment is 1,359 students – up 3 students from last year.

Financial Value Transparency

The Department of Education has released new <u>Financial Value Transparency and Gainful Employment Rules</u> (FVT/GE). This impacts institutions that receive Title IV Federal Student Aid and became effective July 1, 2024. These rules have two outcomes:

- 1. Provide prospective students with information about financial outcomes
- 2. Establish minimum debt to earnings thresholds and accountability for programs that do not meet those thresholds

The Department of Education is establishing new Debt-to-Earnings ratios (D/E rates) and an Earnings Premium measure (EP measure) as measures of financial outcomes that prospective students and their families should consider in evaluating whether to pursue a particular educational program.

As part of the mandated reporting, we must collect information about which graduate programs require a licensure or certification in order to practice in the degree and how many graduates passed a licensure/certification exam. If licensure or certification is optional for practice, we don't have to report it. This is a critical part of the program metrics, and we need this information from you. If you have multiple programs in the same CIP code (such as a master's/doctoral degree or a certificate/master's degree), please report separately for each program.
