II. Consider Approval of the Minutes of the Academic Affairs Committee Meeting of May 16, 2024

Item A. Report on Faculty Highlight, Department of Management and Marketing, College of Business, Denton Campus

Dr. Angela Bauer, Executive Vice President for Academic Affairs and Provost, provided introductory information related to artificial intelligence ("AI") and its applications in higher education and then introduced Dr. Lee Brown, Associate Professor of Management and Associate Dean of Research and

Innovation, to the Board. Dr. Brown presented information to the Board related to the College of Business' implementation of AI in the classroom, training of TWU students in AI tools to prepare them for workforce, and faculty use of AI in teaching to improve the student experience. Dr. Brown then provided information related to University-wide AI initiatives and concluded his report by affirming the College's commitment to leading in AI education.
