I. Call Special Called Meeting to Order

With a quorum being present, Regent Wright, Chair of the Board of Regents, called the Special Called Meeting of the Board of Regents to order at **5:01 p.m.**

Regent Wright reminded everyone that the meeting is being streamed live and asked that everyone speak loudly and clearly as they make comments during the meeting. She reminded everyone to clearly identify themselves when speaking.

II. Recess to Executive Closed Session

Regent Wright announced that the Board would recess into Executive Closed Session for Deliberations Regarding Personnel Matters Relating to Appointment, Employment, Evaluation, Reassignment, Duties, Discipline, or Dismissal of Public Officers or Employees pursuant to Section 551.074 of the Texas Government Code. Specifically, she stated that the Board would discuss personnel matters related to the Chancellor.

Regent Wright stated that Mr. Jason Tomlinson, Senior Vice President for Finance and Administration, would join the Executive Closed Session.

The meeting recessed at **5:03 p.m.**

III. Reconvene to Open Session and Take Any Possible Action Regarding Matters Discussed in Executive Closed Session

At the conclusion of the Executive Closed Session, Regent Wright reconvened the Special Called Meeting of the Board of Regents into open session, a quorum being present at **5:21 p.m.**

Regent Wright commended Dr. Carine M. Feyten, Chancellor and President, for her leadership at TWU since 2014. She also recognized the previous contributions of Mary Eleanor Brackenridge, who helped found TWU and served on the Board of Regents for over 20 years.

Regent Wright noted for the record that **Item A.1** would consist of three parts:

Part 1: Rename the building known as the “Mary Eleanor Brackenridge Student Center Annex” to become the “Carine Feyten Student Center Annex.”

Part 2: Name the Welcome Center, which was unnamed, the “Carine Feyten Welcome Center.”

Part 3: Rename the building known as the “Admissions Building” to become the “Mary Eleanor Brackenridge Building.”

Motion to Approve Item A.1 Deliberations Regarding the Chancellor’s Leadership Milestones and Associated Personnel Matters, with Possible Action: Regent Amirkhan motioned and Regent Wilson seconded. The motion passed with a unanimous vote.

IV. Adjourn Special Called Meeting

With no further business coming before the Board of Regents, Regent Wright adjourned the Special Called Meeting of the Board of Regents at **5:24 p.m.**
