**Scott Martin** The minor exists in the catalog had a board options on which art history course could be taken to fulfil the requirements and it became an issue with advisors that they were sending add/drop forms to the registrar's office.

**Dr. Colby Parsons:** Currently this is our only minor that is left that gives the students broad range to pick any classes for this program and we feel that with the modifications this gives students clarity with specific classes and provides better groundwork to understand the upper-level classes. The required courses would give the student a better context for upper-level classes.

- ii. Accelerated B.S. in Sociology/M.A. in Sociology

  - **Dr. Williams:** No, we do not expect to need additional faculty. We want to start slow and grow the program over 3-4 years. We want to admit strong students who have a good potential for success. We are requiring a recommendation from a Sociology faculty member and a GPA of at least 3.5.

iii. B.S/B.A. in Political Science – All four degrees will be presented together but voted on separately.

**Dr. Jerry Burkett:** Are the student learning objectives more aligned with the Legal Studies versus the Politics Policy?

Jennifer Danley-Scott: The learning objectives are generally more aligned with preparing students to work in the public sector. Political Science is still reviewing the learning objectives for Texas and American government, which will be the next step in our process. This is especially important since many of the courses focus on women, and we are waiting to see what the state legislature decides. Additionally, due to the recent faculty retirements, there is an increased focus on ensuring that the courses offered align with both student needs and institutional goals.

**Dr. William Benner:** If a student wants to go on to law school is there one in particular that is attractive to that student or is it pretty flexible that you get a little bit of everything with these degrees?

**Jennifer Danley-Scott:** They get a little bit of everything, but when you start to look at what's in the Legal Studies emphasis, they are taking far more classes in criminal law. For example, if they're interested in gender, they might take the *Gender Identity and the Law* course. They'll also take *Constitutional Rights and Criminal Justice*, compared to someone pursuing the Politics, Policy, and Public Service emphasis, who might take more courses like *Women in Politics*—hopefully, we can continue offering that one. That emphasis focuses more on helping students understand policy and advocacy—areas that differ somewhat from the writing and legal preparation typically geared toward law school. Our students generally go in two directions.
